LICENSEE:

The inspection was an examination of the activities conducted under your license as they relate to radiation safety and to compliance with the Nuclear Regulatory Commission (NRC) rules and regulations and the conditions of your license. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector. The inspection findings are as follows:

10 CFR 20.1101(c) requires that each licensee shall periodically (at least annually) review the radiation protection program content and implementation. Contrary to the above as of June 2, 2008, [licensee] had not performed a review of the radiation protection program content and implementation since 7/7/2000. This is a Severely level IV violation - Supplement IV. The radiation safety officer committed to performing the radiation protection program review by the end of June 2008.
