

AREVA NP Inc. (AREVA NP) requested the NRC's review and approval of topical report ANP-10273(P), "AV42 Priority Actuation and Control Module Topical Report" in Reference 1. In Reference 2, the NRC provided a third request for additional information (RAI). AREVA NP had agreed to provide responses to the RAIs in Reference 2 by June 30, 2008. In Reference 3, AREVA NP submitted responses to 21 of the 29 RAIs from Reference 2.

The purpose of this letter is to inform the NRC that the remaining 8 RAI responses will be submitted by August 8, 2008. Ronda Pederson (AREVA NP) discussed this change in schedule with Getachew Tesfaye (NRC Project Manager) on June 26, 2008.

AREVA-NP understands that this extension to the RAI responses still supports the NRC's schedule for issuance of the safety evaluation report by November 20, 2008, as stated in Reference 4.
