

Dear Michelle:

This refers to NRC License Number 32-00426-02, Docket Number 030-05594 as amended June 18, 2007, (Amendment Number 49). The US Department of Commerce, National Oceanic and Atmospheric Administration, National Ocean Service, National Centers for Coastal Ocean Science, Center for Coastal Fisheries and Habitat Research (CCFHR) at Beaufort, NC, wishes to advise you that all research use of radioactive nuclides at CCFHR ended in July 2007. Removal of all research radionuclides was completed on 25 October 2007, by Bionomics, Inc. Removal of all radioactive sources in scientific instruments was completed 1 May 2008, by Beckman Coulter, Inc. CCFHR is proceeding with the procurement of certification of absence of radioactive materials, tentatively scheduled for July 2008.

CCFHR requests cancellation of NRC License Number 32-00426-02. FORM 314 is completed and enclosed.
