B. Additional Filings Regarding Timeliness of Intervention Petition

In its July 1, 2008 answer, applicant Tennessee Valley Authority (TVA) has challenged the timeliness of the filing of the Joint Petitioners<sup>2</sup> June 6, 2008 intervention petition via the agency's E-Filing system. See Applicant's Answer Opposing Petition to Intervene (July 1, 2008) at 2-3. The NRC staff made no such challenge, see NRC Staff Answer to "Petition for Intervention and Request for Hearing by [Joint Petitioners]" (July 1, 2008) at i-ii, but the Board would like the staff's views on this issue. Accordingly, on or before Monday, July 14, 2008, the staff should provide the Board with a filing providing its position regarding this matter. Joint Petitioners may submit a reply to that staff pleading on or before Friday, July 18, 2008.

C. Limited Appearance Statements by Members of the Public

Relative to the opportunity for members of the public to present limited appearance statements in accord with 10 C.F.R. § 2.315(a), the Board does not intend to conduct oral limited appearance sessions at this juncture, although it may do so in the future at a location or locations near the proposed site. In the interim, any person not a petitioner to this proceeding that wishes to make a statement regarding the issues in the proceeding can do so in writing. Limited appearance statements, which are placed in the docket for the hearing, provide
