
Pursuant to 10 CFR 32.72(b)(5) and current license conditions, the following individual will be working at our facility as an Authorized Nuclear Pharmacist:

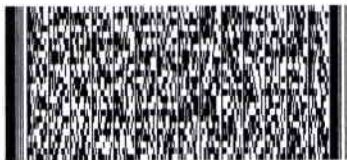
