This letter is an addendum to the report sent to you for the completed decommissioning of the Swiss Army Brands, Inc. facility, located at 65 Trap Falls Road, Shelton, Connecticut. The watch repair area within the building was the only location that had Tritium sources. The watch repair area only repaired and assembled the watches; no painting was done at this location. In addition, as per your request, the following information has been provided:

**Question:** Exact square footage of 65 Trap Falls building and of the watch repair area.

**Answer:** The building is 82,550 sq. ft. and the watch repair area was 3,520 sq. ft.

**Question:** Dimensions of 65 Trap Falls building and of the watch repair area.

**Answer:** The building, starting at the North wall moving West, is 95 x 125 x 25 x 440 x 10 x 50 x 165 x 300 x 100 x 165 x 50 x 200 feet. The watch repair area was 44 x 80 feet.


**Question:** Last day the building contained Tritium.

**Answer:** February 28<sup>th</sup> 2008.

**Question:** History of contamination of Tritium since the start of business.

**Answer:** The building first started holding watches in June of 1990 and began repairing them in August of 2002.
