Please see the enclosed radioactive material license agreement between the Cardiac Care Center of Louisville (CCCL) and The Physician Group at Jewish Hospital & St. Mary's Healthcare, Inc.(TPG) The name on the radioactive material license is Medical Center Cardiologists, PSC, however, Medical Center Cardiologists does business as CCCL.

As of July 1, 2008, The Physician Group at Jewish Hospital & St. Mary's HealthCare, Inc., a Kentucky nonprofit corporation, employed the physicians, allied health personnel and support employees of the Cardiac Care Center of Louisville, PLLC. In addition as of July 1, 2008, TPG purchased some, but not all, of the assets of CCCL as well as accepted assignment of several real property leases and other licenses and contracts.

Other information required is listed below as stated in NUREG-1556 appendix G:

- There are no changes in personnel or duties that relate to the licensed program.
- There are no changes in the organization, location, facilities, equipment, or procedures that relate to the licensed program.
- The surveillance program will not change from what has been: daily surveys will be performed, monthly or as needed wipe tests will be performed, and QC will be performed per the manufacturer's recommendations.
- All records concerning the safe and effective decommissioning of the facility will be transferred to TPG as appropriate. Although decommissioning of the site will not be necessary, all duties will stay the same, any surveys of radiation levels and/or removable contamination will be kept.
- The TPG will abide by all constraints, conditions, requirements, and commitments of CCCL (or Medical Center Cardiologists, PSC). Copies of the policies and procedures are located in the hot lab at the facility.
