**PROGRAM SCOPE**

The licensee was small municipal office employing 100 individuals. The licensee possessed one moisture/density gauge used occasionally for road testing projects during the construction season. The licensee approved 2 individuals (both successfully completed the manufacturer's training course) as authorized gauge users. The licensee did not perform any service or maintenance activities on its gauge; these services were performed by the device manufacturer.

During this inspection, the inspector toured the gauge storage area, surveyed the gauge storage room, interviewed selected licensee personnel, and reviewed selected records. Licensee personnel discussed and demonstrated security measures in the field, transportation procedures and emergency procedures. At the time of this inspection the gauge was not in use. Therefore, the inspector was unable to conduct a field inspection.
