The NRC is in the process of conducting its detailed review of the Combined License (COL) application for North Anna Power Station, Unit 3 (NAPS). As part of our detailed review, the NRC is conducting a Site Audit (at the North Anna site in Louisa County, VA) and public scoping meeting on the NAPS, Unit 3 COL application the week of April 14 and April 16 at 7:00pm, respectively. A DRAFT detailed site audit scheduled is attached

to this email. The public scoping meeting agenda is forthcoming, but our current plan is for the meeting to begin at 700pm with a series of short NRC presentations followed by an approx. 3 hour comment period. The meeting is scheduled to be held April 16 at the Louisa County High School , 757 Davis Highway, Mineral, VA.
