## **AUDIT OF NRC'S CONTINUITY OF OPERATIONS**

#### OIG-08-A-10

### **Status of Recommendations**

Recommendation 1:

Revise current agency guidance governing security surveys of NRC continuity facilities to reflect Federal requirements (as originally stated in Federal Preparedness Circular 65 and superseded by Federal Continuity Directive 1) regarding annual physical security surveys of continuity facilities.

Response Dated June 18, 2008:

Agree. The Office of Administration (ADM)/Division of Facilities and Security (DFS) has implemented an interim policy change to ensure annual physical security surveys are conducted for continuity facilities. We will also revise Management Directive (MD) 12.1 to reflect the Federal Continuity Directive 1 requirement to provide for annual physical security inspections of continuity facilities. The action to revise MD 12.1 will be completed by February 27, 2009.

**OIG** Analysis:

The proposed corrective actions address the intent of the recommendation. This recommendation will be closed when OIG receives documentation that MD 12.1 has been revised to reflect the Federal Continuity Directive 1 requirement to provide for annual physical security inspections of continuity facilities.

#### **Status of Recommendations**

Recommendation 2: Conduct the physical security surveys annually as required

by Federal requirements (as originally stated in Federal Preparedness Circular 65 and superseded by Federal Continuity Directive 1), and maintain appropriate

documentation in accordance with MD 12.1 guidelines.

Response Dated June 18, 2008:

Agree. ADM/DFS conducted a physical security survey for the NRC Headquarters Operations Center June 4, 2008, (report pending) and will conduct a physical security survey of the alternate continuity facility by September 30, 2008. ADM/DFS will also conduct a physical security survey for the

remaining three regional operations centers by

December 31, 2008.

OIG Analysis: The proposed corrective action addresses the intent of the

recommendation. This recommendation will be closed when OIG reviews the headquarters and regional office physical

security surveys.

Status: Resolved.
