Radiation safety was a daily subject during her internship which included radiology and ultrasonography. Dr. Hyman has participated in over 50 cases of nuclear scintigraphy since her start date at VEI with Dr. Allen and has been involved in well over 500 hours of all phases of nuclear medicine. She has been involved in case selection, calibration and operation of the equipment, acquiring the scintigraphs and interpretation and case work up. She has also assisted Dr. Allen on teaching and educating the staff on continuing radiation safety.
