In addressing the Requests for Additional Information (RAIs) provided to the Tennessee Valley Authority (TVA) in the referenced letters, TVA has determined that additional time is necessary to provide the responses. Efforts to reflect the change from the original reference to the industry template (NEI 07-11) to a specific COL application calculation with specific COL application FSAR revisions have been more complex than originally anticipated. The complexity has resulted in the need for additional time to provide the response including revised FSAR content. TVA has reviewed the NRC review schedule, and has determined that Phase 2A (RAI response review) for Chapter 11 is scheduled to begin on August 11, 2008. Therefore, TVA will submit the responses to the RAIs contained in the referenced letters on or before August 6, 2008. It is anticipated that the Phase 2A review schedule for Chapter 11 will be unaffected by this minor change in providing the responses.
