Ron:

For No. 1, what I meant to say was that COGEMA has removed the sludge and liners from all but two of their evaporation ponds at Irigaray. That is, only two of their ponds are currently operational (RB and B). All of the Christensen Ranch ponds are operational, as far as I know.

For No. 2, I have not actually seen anything in writing about EPA's reluctance (at least from EPA) to issue or renew Class I disposal wells injecting into the Lance Fm. However, Energy Metals/Uranium One's proposal to our Water Quality Division last week to issue a Class 5 disposal permit for water disposal (into the Lance) strongly suggests that is the case.

Hope this clarifies things.

Glenn:

Thanks for discussing the COGEMA draft EA with me Monday. I just want to confirm I've captured your comments.

- 1. We discussed that COGEMA had removed liners and byproduct material at two of their evaporation ponds at Irigaray and that they would need to refurbish those ponds prior to use.
- 2. COGEMA's Class I wells for deep well injection are into the Lance Formation and EPA has indicated that they may not want to allow injection into that formation in the future. This may become an issue for COGEMA in the future as their Class I permits come up for renewal.
