During the week of June 16, 2008, representatives of the NRC Office of New Reactors and supporting contractors conducted an Environmental and Safety Site Audit of the Grand Gulf Nuclear Station (GGNS) Unit 3 combined operating license application (COLA). During the audit, the NRC staff requested various electronic files to aid in Staff review of the application; specifically, Part 2, FSAR Section 2.4, *Hydrologic Engineering*. Attachment 1 provides a listing of the NRC's safety (hydrology) requests with Entergy's responses. The numbering convention used in Attachment 1 (e.g., H-3) was developed to track the questions raised during the audit. Enclosure 1 provides a DVD containing the electronic hydrology files requested. Attachment 2 provides a list of files contained on the enclosed DVD. All files are publically available.

The file format and names on the enclosed DVD do not fully comply with the requirements for electronic submission in NRC Guidance Document, "Guidance for Electronic Submissions to the NRC," dated November 20, 2007; the files are not "*.pdf" formatted. The NRC Staff requested the files be submitted in their native formats required by the software in which they are utilized to support the FSAR development; e.g., ASCII for input files to the HEC-RAS software. The file names are those required for proper software operation.
