To Whom It May Concern:

There has been a transfer of control concerning License No. 21-26282-01. On December 5, 2005 Hayes Lemmerz International, Cadillac Inc. was sold in its entirety to Cadillac Castings, Inc. This change of ownership was relayed to the NRC Accounts Receivable Team but I believe at this point, that our attempt to notify you was sent to the wrong address and subsequently not followed up on by me. A recent NRC inspection by Geoff Warren has brought this issue to my attention.

Information concerning changes of control;

- 1) The name of our company is now Cadillac Casting, Inc. The management team is essentially the same and I, Erik Olson am still the RSO.
- 2) There has been no change in personnel related to the licensed program.
- 3) There has been no change to our location, facilities, equipment or procedures relative to the licensed program.
- 4) The status of the surveillance program has not changed. We continue to perform leak tests every three years. Surveys and quality control have been on going with no change relative to the licensed program.
- 5) Confirmation that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to the NRC, as appropriate is not applicable. We continue to use the licensed device for its purpose.
- 6) Cadillac Casting, Inc. will continue to abide by all constraints, conditions, requirements and commitments of the transferor.
