The purpose of this modification is to:

1. Exercise Option Year #1 in accordance with FAR Clause 52.217-9
2. Revise Section F.1 Duration of Contract Period (MAR 1987) Alternate 4 (JUN 1988)
3. Increase the contract ceiling
4. Revise Section B.3 Consideration and Obligation – Delivery Orders (JUN 1988)

Contract NRC-37-06-351 is hereby modified as follows:

1. Option Year #1 is hereby exercised in accordance with Section I.6 - FAR Clause 52.217-9. Therefore, the period of performance is hereby extended to 09/26/2009.
2. Sentence one (1) of Section F.1 – Duration of Contract Period (MAR 1987) Alternate 4 (JUN 1988) is hereby revised as follows:

“The ordering period for this contract shall commence on September 27, 2008 and will expire on September 26, 2009.”
3. The current contract ceiling is hereby increased by \$186,200.00 from \$334,400.00 to \$520,600.00. The total contract ceiling shall remain at \$893,000.00.
4. Sentence one (1) of Paragraph (a) of Section B.3 Consideration and Obligation – Delivery Orders is hereby revised as follows:

(a) “The total estimated amount of this contract (ceiling) for products/services ordered, delivered, and accepted under this contract is \$520,600.00.”
