The purpose of this modification is to exercise option period three (3), increase the ceiling of the Delivery Order, and revise Sections A.2 and A.6 of the Delivery Order.

1. Option period three (3) is hereby exercised, extending the period of performance to 8/31/2009. FAR 52.217-9 applies.

2. The contract ceiling is increased by \$124,000.00 from \$303,000.00 to \$427,000.00.

3. Section A.2 Paragraph (a) is hereby modified to:

“The total estimated amount of this contract for the products/services ordered, and accepted under this contract is \$427,000.00 (August 1, 2006 through August 31, 2009). The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract.”

4. Section A.6 Paragraph (a) is hereby modified to:

“Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from August 1, 2006 through August 31, 2009.”
