

**PROGRAM SCOPE**

The licensee was a private manufacturing firm specializing in products for the automotive industry. At the time of this inspection the licensee possessed two americium-241 thickness gauges. Due to local economic changes, in 2007, the licensee ceased use of its production line where the gauges were installed. Currently the licensee employs one individual who have been trained by the manufacturer in the safe use of the gauges. The gauges were stored in a labeled, locked job box. However, the inspector was concerned about the vicinity of the job box to equipment slated for dismantlement and sale to another firm. The inspector expressed this concern to the licensee management and previous incidents involving inadvertent disposal/transfer.

During this inspection, the inspector toured licensee's plant, performed radiation surveys around the gauge storage container/job box and the immediate working areas, reviewed selected records, and interviewed licensee personnel.

Between June 10-27, 2008, the inspector attempted on several occasions to contact the licensee. The purpose of these contacts was to establish an understanding of the licensee's intent for the disposal/transfer of its gauges and the additional measures taken to maintain security of the gauges. Attempts to contact the RSO, the maintenance manager and the senior management were unsuccessful. The inspector conducted another unannounced inspection on July 7, 2008, and successfully contacted licensee senior management to discuss the licensee intent on disposal of the gauges. The licensee re-affirmed its intent to dispose of the gauges and committed to prioritize the transfer transaction. On July 31, 2008, a licensed service company packaged and transferred the gauges for storage/disposal. Follow up discussions with the licensee confirmed their intent to terminate the NRC license. The inspector advised the licensee on the process to terminate the NRC license.
