We are looking forward to meeting with you, Michael and Christopher on Saturday about 9:30 or 10 or when ever you get here. We understand that you will be leaving Rockville about 7 a.m. Attached are directions from the capital beltway (Rt 495) getting onto Rt 66, etc. We do not recommend that you come down Rt95 on a weekend, as there are many traffic tie-up's.

We will have a total of 5 persons representing the Friends of Lake Anna, Lake Anna Civic Association and the Lake Anna Boating and Recreation Association to discuss our environmental concerns with the proposed 3rd reactor. Note that none of the group's are anti-nuclear, nor have not-in-my backyard sentiments.

I will have coffee and doughnuts when you get here.

We get then meet for about 2 hours or so and get a quick bite to eat. I will provide a small lunch (barbecue & potatoe salad & drinks) .
