

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to increase the obligated amount by \$30,483.32 from \$700,000 to \$730,483.32. Accordingly, the contract is modified as follows:
First sentence of Paragraph (b) of Section B. 3, entitled "Consideration and Obligation" is revised to read as follows:
"The amount presently obligated with respect to this contract is \$730,483.32."

All other terms and conditions remain the same.
