

The purpose of this modification is to exercise option year two, extend the period of performance and obligate funds.

The purpose of this modification is to 1) provide incremental funding in the amount of \$362,408, thereby increasing the obligated amount under the contract from \$724,738.00 to \$936,798.00 and 2) to exercise Option Year 1.

Accordingly, the changes are made to the terms and conditions:

1) Section B.3 CONSIDERATION AND OBLIGATION – COST PLUS FIXED FEE (JUN 1988) ALTERNATE is revised to read as follows:

(a) The total estimated cost to the Government for full performance of this contract is ~~\$1,461,693.00~~, of which the sum of ~~\$1,359,754.00~~ represents the estimated reimbursable costs, and of which ~~\$101,939.00~~ represents the fixed fee.

(c) The total estimated cost to the Government for **OPTION YEAR 2** is **\$760,345.00**, of which the sum of **\$707,116.00** represents the estimated reimbursable costs, and of which **\$53,229.00** represents the fixed fee.

(d) The total estimated cost to the Government for **OPTION YEAR 3** is **\$784,824.00**, of which the sum of **\$729,834.00** represents the estimated reimbursable costs, and of which **\$54,990.00** represents the fixed fee.

(e) The total estimated cost to the Government for **OPTION YEAR 4** is **\$810,152.00**, of which the sum of **\$753,340.00** represents the estimated reimbursable costs, and of which **\$56,812.00** represents the fixed fee.

(f) The amount currently obligated by the Government with respect to this contract is ~~\$936,798.00~~, of which the sum of ~~\$872,158.94~~ represents the estimated reimbursable costs and of which the sum of ~~\$64,639.06~~ represents the fixed fee.

(g) It is estimated that the amount currently allotted will cover performance through ~~January 1, 2009~~.

2) Section F.6 is revised to read as follows:

This contract shall commence on ~~August 7, 2008~~ and will expire on ~~August 6, 2009~~. The term of this contract may be extended at the option of the Government for an additional ~~three (3)~~ years.
