The purpose of this modification is as follows:

1. To change the title of a system from High Performance Computing Systems (HPCS) to Consolidated High Performance Systems (CHPS).
2. To provide incremental funding in the amount of \$18,000.00, thereby increasing the obligated amount from \$1,883,084.22 to \$1,901,084.22.
