
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to provide incremental funding for DR-10-06-397.
PERIOD OF PERFORMANCE: 12/01/2006 - 11/30/2008

The ceiling of subject contract was increased by \$44,940.48 in Modification No. 3 from \$84,781.20 to \$129,721.76. The obligated funds on the subject contract are increased by \$29,940.00 from \$71,500.00 to \$101,490.00.
