WHEREAS, it was recently reported that Unistar Nuclear may be in the process of locating a new power plant in the State of Maryland, and the State of Maryland may not welcome the construction of a new power plant, and

WHEREAS, the Greater Oswego, NY Community would welcome the construction of a new power plant in our area, and

WHEREAS, the construction of a new power plant would mean the potential employment of over 1500 trained crafts men and women during the construction phase and over 500 permanent jobs during the operational phase, and

WHEREAS, the Greater Oswego, NY Community has a pool of highly-trained, experienced, and qualified construction workers, and

WHEREAS, the Greater Oswego, NY Community, along with all of Upstate New York, is witnessing a sluggish economy and lack of employment opportunities, and

WHEREAS, the job opportunities provided by the construction and operation of a new power plant would greatly enhance our local employment situation and local economy; now, therefore, be it

RESOLVED, that the administration and Common Council of the City of Oswego, New York, do hereby officially welcome and endorse the idea of constructing a new power plant in our area; and be it further
