PROGRAM SCOPE

Licensed activities were not conducted during the inspection. The RSO was the only authorized user. The licensee possessed a Humboldt Model 5001, Serial 4558 moisture/density gauge and a Troxler Model 3241-C, Serial 2568 asphalt content gauge. The licensee used the Humboldt gauge at temporary job sites about three times per year. The licensee periodically used the Troxler gauge at the base facility only.

PERFORMANCE OBSERVATIONS

The inspector observed: (1) staff secure licensed material as required; (2) that the licensee had posted the facilities as required; (3) the RSO demonstrate how the Humboldt gauge was transported and used at temporary job sites; (4) the RSO demonstrate how leak test samples were taken; (5) the RSO demonstrate response to a damaged gauge at a temporary job site based on a scenario posed by the inspector; and (6) the RSO use personnel dosimetry badges.
