Deaconess Hospital would like to amend its NRC Byproduct Materials License, Number 13-00142-02, to add 421 Chestnut Street, Evansville, Indiana, 47713 as an Address of Use. The proposed address of use is currently listed on the USNRC Byproduct Materials License of Welborn Clinic, Number 13-32371-01. Deaconess Hospital and Welborn Clinic are merging and we request that the Welborn Clinic USNRC License be terminated simultaneous with the 421 Chestnut Street address of use being added to the Deaconess Hospital USNRC License. The effective date of the merger is August 1, 2008 and we wish to have no interruption of services involving radioactive materials during the transition period. Further, we request that the use radioactive materials licensed under 10 CFR 35.100, 35.200, and 35.300 continue to be licensed at the 421 Chestnut Street address of use.

In addition, we request that Mark Graves, M.D. recently added to the Deaconess Hospital License as an Authorized User of materials licensed under 10 CFR 35.100, 35.200, and 35.300, be the only Authorized User at the Welborn Clinic at this time.
