We have a problem in viewing the New & Significant Information in Richland. Tuesday, Terri Miley and I did a dry run. We went down to the office after having called beforehand (no answer - turned out the number was incorrect). Everything went well, the receptionist knew about it and let us in. Today, staff members were refused entry to the room because their name was not on "a list".
