**FINAL REPORT DISTRIBUTION PLAN FOR EMPLOYEE CONCERNS**

This letter is to confirm NRC's planned participation in TVA's effort to disseminate information through the Employee Concerns Special Program (ECSP) review station at Sequoyah Nuclear Plant (SQN), as noted in item 4 of the letter dated September 30, 1987.

At this time, we request that you extend this offer of assistance to Browns Ferry, Watts Bar, and Bellefonte Nuclear Plants. As you note, participation would involve an NRC representative onsite to provide concerned individuals (CIs) with their concern number(s) upon their request and proof of identification. Additionally, we request that NRC provide CIs with report numbers corresponding to their concern number(s).

Stations will be operated consecutively at each nuclear site beginning with SQN in early January. This effort is expected to be completed in March 1988, although no firm schedule has been established. The duration will be five to eight working days at each site.

Regarding other comments in the September 30, 1987 letter, we have revised the steps the CI must take to review a report. Subcategory reports will be the primary device offered; however, SQN element reports, the category report (including management and personnel and industrial safety subcategory reports), and the program report will be available at each review station.


