We have reviewed the proposed changes to the Ohio regulations Administrative Code Chapters 3701:1-38 "General Radiation Protection Standards for Sources of Radiation", 3701:1-40 "Licensing Requirements for Radioactive Materials" and 3701:1-46 "General Licenses and Licenses for Manufacturing and Distribution", received by our office on June 17, 2008. These regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Parts 19, 20, 30, 32, 150 and the requirements of the two amendments identified in the enclosed State Regulation Status (SRS) Data Sheet.
