**Response to NRC Request for Additional Information Concerning

By letter (L-2008-001) dated February 11, 2008, Florida Power & Light Company (FPL), the licensee for the St. Lucie Nuclear Plant, Units 1 and 2, and the Turkey Point Nuclear Plant, Units 3 and 4; FPL Energy Seabrook, LLC (FPL Energy Seabrook) the licensee for Seabrook Station; FPL Energy Duane Arnold, LLC (FPL Energy Duane Arnold) the licensee for Duane Arnold Energy Center; and FPL Energy Point Beach, LLC (FPL Energy Point Beach) the licensee for Point Beach Nuclear Plant, Units 1 and 2, submitted the required written response to NRC Bulletin 2007-01, "Security Officer Attentiveness."

By letter dated July 1, 2008, the NRC staff requested additional information in order to complete their final assessment of FPL's response to the Security Bulletin. The NRC staff requested the additional information within 45 days of the date of their request (i.e., on or before August 15, 2008).

The purpose of this letter is to provide the additional information requested by the NRC staff. Attachment 1 provides the requested information for St. Lucie Units 1 and 2. Attachment 2 provides the requested information for Turkey Point Units 3 and 4. Attachment 3 provides the requested information for FPL Energy Seabrook Station.
