NUCLEAR POWER - ORGANIZATION AND SENIOR MANAGEMENT CHANGES

This is to inform you of changes in senior management and organization. As previously discussed with your staff, R. A. Pedde has resigned as Watts Bar Site Director. The Watts Bar Site Director's office has been eliminated, and Dan Douthit was appointed as Program Manager for Watts Bar's new Project Office, which has responsibility for construction, startup, and overall site management. Mr. Douthit and John A. Scalice, who was hired as the Watts Bar Plant Manager, report directly to the Vice President, New Projects.

Additionally, T. J. McGrath was selected to the new position of Manager, Nuclear Safety Oversight and Executive Staff. This position combined the functions of the Senior Vice President's staff manager and the Nuclear Safety Review Board Chairman. In this position, Mr. McGrath will serve as Nuclear Safety Review Board Chairman replacing W. H. Hannum.

In addition to the above organizational changes, Sequoyah Site Director John LaPoint has resigned his position effective November 27, 1989. The Vice President, Nuclear Power Production will assume the Sequoyah Site Director functions on a temporary basis and provide overall site management until a new site director is named. Other changes in managers include:

- o C. C. Mason resigned as Manager, Maintenance and Operations Support a replacement has not been named.
- O Lawrence B. Durham has been named Manager of Nuclear Training, effective November 21, 1989.
- o Calvin Vondra has assumed the duties as Sequoyah Nuclear Plant Manager.
- o W. S. Raughley, Nuclear Power's Chief Engineer, has been assigned to the New Projects organization to head the engineering efforts. Mr. Raughley, as New Projects Engineering Manager, will oversee the engineering work on both Watts Bar units, and P. R. Mandava, Watts Bar Project Engineer, will report to Mr. Raughley.

Your July 28, 1987 letter transmitting the Safety Evaluation Report on TVA's revised Corporate Nuclear Performance Plan requested we notify you of any permanent change in the organization or permanent replacement of senior managers, including Site Directors. This information is supplied in accordance with our commitment to keep you advised of these changes.
