PROGRAM SCOPE

The licensee is the civil engineering division of the county road commission located in St. Clair Michigan. They perform soil density and asphalt testing in the county. The licensee has three Troxler 3440 series gauges. The gauges are normally stored at licensee's facility. Licensee does not store its gauges at temporary job sites. The licensee does not performed any service or maintenance activities on the gauges. The licensee employees six gauge users who have completed the manufacturers training.

Performance Observations

Licensee described procedures used at jobsites since no such jobsite was available at the time of this inspection. Interviews of licensee personnel indicated an adequate level of knowledge of radiation safety. The gauges were secured in a manner consistent with the two barriers rule.
