**DOMINION VIRGINIA POWER**  
**NORTH ANNA UNIT 3 COMBINED LICENSE APPLICATION**  
**PLAN FOR RESPONDING TO REQUESTS FOR ADDITIONAL INFORMATION ON**  
**EMERGENCY PLANNING ISSUES**

The purpose of this letter is to inform NRC of Dominion Virginia Power's (Dominion) plan for responding to Requests for Additional Information (RAIs) issued by NRC or FEMA associated with emergency planning (EP) for North Anna Unit 3. To date, the NRC has issued three RAI letters that contain one or more questions related to EP:

- RAI Letter No. 15, dated July 7, 2008
- RAI Letter No. 18, dated July 18, 2008
- RAI Letter No. 19, dated July 21, 2008

Each NRC letter requested that Dominion respond within 45 days, i.e., the responses are due August 21, September 2 and September 4, 2008, respectively. At present, no additional NRC RAIs are anticipated.


The NRC staff has also indicated that FEMA will be issuing RAIs on emergency planning. Discussions regarding the details of that process are taking place, but will clearly involve close coordination between Dominion and various state and local authorities.

Because of the potential for interaction resulting from the RAIs issued by the two Federal agencies, Dominion plans to provide a consolidated response. This holistic approach is intended to ensure that EP-related issues have been thoroughly and consistently addressed. For planning purposes, it is assumed that the time afforded to Dominion to respond to the FEMA RAIs will be consistent with the precedent set by NRC. Thus, Dominion intends to respond to both the NRC and FEMA EP-related RAIs no later than 45 days after FEMA issues its formal RAI letter.
