

SUBJECT: SENIOR MANAGEMENT CHANGES

We have reviewed your letter dated February 14, 1989, providing the staff with written notice of recent senior nuclear power management changes within the Tennessee Valley Authority (TVA). This information was sent in accordance with the staff's Safety Evaluation Report (SER) dated July 20, 1987, on TVA's Corporate Nuclear Performance Plan (CNPP).

Your letter stated that the TVA Nuclear Support operations and Nuclear Quality Assurance operations have been combined into a single new organization. The senior managers in both operations will report to the head of the new organization at least on an interim basis. You conclude with the statement that this final organization requires NRC staff approval. We agree with you that we must review this new organization. The appropriate mechanism to provide the staff with the necessary information is through a revision of the CNPP.

The CNPP is part of TVA's response to the Nuclear Regulatory Commission's 10 CFR 50.54(f) letter of September 17, 1985, regarding Browns Ferry, Sequoyah, Watts Bar and Bellefonte. As such, the staff's SER on the CNPP was part of the staff's documented bases for supporting the restart of Sequoyah Units 1 and 2 in 1988, as well as the current staff review of the restart of the Browns Ferry Unit 2. As there was a significant reorganization of the Nuclear Power organization on July 1, 1988, we request that you submit a revision to the CNPP within 60 days of the receipt of this letter. Although sometime in the future you will no longer be required to submit revisions to the CNPP, the CNPP must be kept up-to-date until the TVA nuclear power program is sufficiently recovered.
