This shipment consists of 60 x 48Y Cylinders loaded on one river barge. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U is 492,000 kgs. The net weight of U-235 is 3,480 kgs.

3) Transportation and Route Schedule

The surface transportation from Metropolis, IL to Paducah, KY will be the responsibility of TAM International Inc. The US inland waterway transportation from Paducah, KY to New Orleans, LA will be the responsibility of Osprey Line. The ocean transportation from New Orleans, LA to Rotterdam, The Netherlands will be the responsibility of Atlantic Ro-Ro Carriers. Export from the United States will occur at New Orleans, LA on or about July 2, 2008.
