On June 15, 2006, the Department of Energy issued a favorable foreign ownership, control, or influence (FOCI) determination (Reference 1) for USEC Inc. and its subsidiaries. Please find an updated Owners, Officers, Directors and Executive Personnel (OODEP) listing for USEC Inc. in Enclosure 1, and an updated listing for United States Enrichment Corporation in Enclosure 2.

USEC specifically requests that the information contained in the Enclosures be withheld from public disclosure. 10 CFR 2.390(a)(6) and 9.17(a)(6) state that personnel and medical files and similar files, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, are exempt from public disclosure. The Enclosures contain personal information of this nature.

On July 10, 2008, the NRC sent a request for an annual FOCI certification (Reference 2). That request, with a response due on August 10, 2008, appeared to be out of cycle with the timing of previous years' annual submissions. Coordination with Mr. Keith Everly from your office and Ms. Peggy Jackson from DOE, Oak Ridge confirmed that both the USEC Inc. and United States Enrichment Corporation's annual submissions would be required during November/December 2008.
