The purpose of this modification is to de-obligate funds in the amount of \$3,506.07, thereby decreasing the ceiling and obligated amount from \$96,88.07 to \$93,362.00.

Accordingly, the following changes are hereby made:

Section 4.0 FUNDING, Paragraphs (a) and (b) are deleted and replaced with the following:

- “(a) The total estimated amount (ceiling) for the products/services ordered, delivered, and accepted under this task order is \$93,362.00.
- “(b) The amount presently obligated with respect to this task order is \$93,362.00. The Contractor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated.
