The purpose of this modification number 011 is to provide incremental funding in the amount of \$140,000, thereby increasing the obligated amount in the contract from \$796,623 to \$936,623 and to revise Section B.1 Price Schedule - Option Year 3 to reallocate costs from CLINs No. 038 to CLIN 037 and 039 to cover two additional G205 Root Cause Workshops. Accordingly, the contract is modified as follows:

1. Section B.1, Price Schedule, Option Year 3 is revised to the following:  
CLIN 037 – Present Course (G205) Root Cause Workshops quantity is increased from 8 to 10 workshops, at a cost of \$49,416; CLIN 038 - Additional Students over 15 is reduced from \$104,480 to \$48,816 a decrease of by \$55,664; and CLIN 039 – Estimated Travel Costs is increased by two trips at a cost of \$6,248. This pricing adjustment has no affect on the Total Price for Option Year 3 which remains at \$568,789.

Option Year 3: Delete CLINs 037, 038, and 039 in their entirety and replace with the following:

2. Section B.2, Consideration and Obligation-Delivery Orders (JUN 1988), the first sentence in paragraph (b), as modified in Modification No. 11 is deleted and substituted with the following in lieu thereof:

“(b) The amount presently obligated with respect to this contract is \$936,623.”

Total FY2006 Obligations: \$224,623  
Total FY2007 Obligations: \$172,000

CUMULATIVE OBLIGATIONS: \$936,623

This modification obligates fiscal year 2008 funds in the amount of \$140,000.

All other terms and conditions of the subject contract remain unchanged.
