Safeguards Contingency Plan, Revision 6

In accordance with 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC, (EGC) is submitting Revision 6 to the Braidwood Station Security Plan. The change to the Braidwood Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan was implemented on July 21, 2008. In accordance with 10 CFR 50.54(p)(2), EGC is submitting this change within 60 days of implementation (i.e., September 19, 2008).

The Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan have been revised to:

- Eliminate the description of a contracted security entity because the security force has changed to an organization consisting of Exelon Energy Company, LLC (Exelon) and an Exelon Energy Company, LLC agent.
- For Central and Secondary Alarm Stations (CAS/SAS) operators, the requirement to complete a physical fitness test and qualify with firearms has been removed from the Appendix B, Training and Qualification Plan because these individuals are not required to be armed.

EGC has concluded that the changes do not decrease the safeguards effectiveness of the Braidwood Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan.


