Would you possibly consider extending that date by a day or two? I don't think too many people know about the scoping meeting yet, and I have seen little publicity about it.

Also, most of the hearings that we attend, EPA and state TCEQ hearings, allow sign up to occur throughout the meeting time, and I'd like to request that you consider that possibility too.  
For example, a person might not be able to get off work until 3:30, and they should be allowed to speak if there is no one speaking at that time. It is not typical in my experience to require that everyone who wants to speak be there and sign up within 15 minutes of the start of the hearing.

Please advise me as to your willingness to consider these requests in order to better serve the public in this process.
