The purpose of this memorandum is to transmit to you updated copies of the computer printouts listing employee concerns in the Industrial Safety category and the Management and Personnel category. If a concern contains safety related information, it has been shared with a technical category whose evaluators will address that portion of the concern. The two printouts labeled ECPS120J - ECPS122C are a numerical listing of all employee concerns in the Industrial Safety category and in the Management and Personnel category.

The two printouts labeled ECPS120J - ECPS121C are a listing by category of the employee concerns. This printout is sorted into the subcategories to which the concerns have been assigned by the responsible group head.

This information was discussed with B. K. Singh of your staff and confirms that no safety related or safety significant issues are being addressed in these two categories.


