
**THE NUCLEAR ENERGY INSTITUTE'S CERTIFICATION OF
LICENSING SUPPORT NETWORK SUPPLEMENTATION**

Governing regulations require that each potential party to the instant proceeding continue to supplement its documentary material made available to other proceeding participants via the Licensing Support Network ("LSN") with any additional material created after its initial certification. 10 C.F.R. § 2.1003(e). Pursuant to this requirement, the Pre-Application Presiding Officer ("PAPO") Board has ordered that each potential party make the required supplementation on or before the first of each month following its initial certification, and file a certification to that effect. Revised Second Case Management Order (Pre-License Application Phase Document Discovery and Dispute Resolution) (July 6, 2007) ("RSCMO") at 21.

The Nuclear Energy Institute ("NEI") made its initial certification on January 11, 2008 and its previous certification of supplementation on July 30, 2008. Accordingly, Steven P.
