Dear Mr. Murray:

This is in response to your letter dated April 18, 2008, by which you transmitted a revision to the Radiological Emergency and Contingency Plan (RC&EP), for the Global Nuclear Fuel-Americas facility in Wilmington.

By review of the submittal listed above, the U.S. Nuclear Regulatory Commission (NRC) determined that the revision was correctly submitted under the provisions of Title 10 of the *Code of Federal Regulations* (10 CFR), Section 70.32(i) and the changes do not decrease the effectiveness of the RC&EP. Accordingly, the changes to the RC&EP are acceptable, and License Condition S-3 of license SNM-1097 will be updated in a future amendment to reflect the current revision.

TAC L32679 is closed.

All other conditions of this license shall remain the same.
