Bill,

I would like to see the following: discharge canal where it dumps into Waste Heat Treatment Facility, water intake location, locations of external radiation sources onsite (e.g., ISFSI), location of TLDs on protected area fence (ones used as basis for construction worker dose estimates), location of proposed Unit 3 site, and location of nearest receptors (residence, meat cow, and vegetable garden). Some of the external radiation sources are inside the Unit 1 and 2 protected area, they can just be pointed out to me (I don't need to enter the protected area).

The bottom line is I don't need to go inside of Units 1 or 2.
