-The per diem is 70/39/109.

-There is reason to believe the 2008 POV cost is actually 50.5cents/mile. At this time GSA's website is still quoting 48.5cents/mile, I'll keep you informed of what I find out.

-The Louisa County High School is located at 757 Davis Hwy, Mineral, 23117.
