NQA PLAN CHANGE

The existing NQA Plan in Section 4.1.5 reads as follows:

Present wording:

4.1.5 New Generation and Bellefonte Construction (NG&BC)

In addition to the responsibilities described in subsection 4.1.2, the Vice President, NG&BC has responsibility to implement the deferred plant QA program requirements as identified in Appendix F.

Change to read:

4.1.5 New Generation and Bellefonte Construction (NG&BC)

In addition to the responsibilities described in subsection 4.1.2, and responsibility to implement the deferred plant QA program requirements as identified in Appendix F, the Vice President, NG&BC has overall responsibility for development and implementation of programs at Bellefonte Nuclear Plant (BLN), ensuring that the QA requirements of this plan are appropriately established in BLN site procedures.

Justification for change:

This change describes responsibility of the Vice President, New Generation and Bellefonte Construction (NG&BC), for development and implementation of procedures at the BLN site. In developing site procedures, the Vice President, NG&BC, ensures the QA requirements of the Plan are appropriately established in BLN site procedures. This implements the Nuclear Quality Assurance Program policy statement for holding line management responsible for establishing quality requirements in procedures, and accountable for compliance with quality requirements.
