**CORPORATE NUCLEAR PERFORMANCE PLAN (CNPP)**

Revision 6 to the TVA CNPP was submitted to NRC on May 5, 1989. Since that time, TVA has completed all but one of the commitments with corporate responsibility contained in Appendix 8. The exception is the commitment related to the configuration management system upgrade. Work on this long term commitment is currently ongoing and is scheduled through the integrated living schedule. The other commitments were completed in accordance with TVA's standard for commitment management. This standard requires verification that commitments are completed as stated in the correspondence to NRC. The process for completing corporate commitments includes QA monitoring and has also been inspected and found acceptable by NRC.

In addition to the corporate commitment, three commitments remain open for Bellefonte Nuclear Plant (BLN). The open Appendix 8 BLN commitments are Nos. 27, 29, and 30. BLN is currently in a deferred status and work on these commitments will be delayed until decisions are made to reactivate the project. However, these commitments are captured in the Tracking and Reporting of Open Items system and will be closed in accordance with TVA's requirements for commitment closure if BLN project is reactivated. TVA considers that the CNPP has served its usefulness and sees no benefit in maintaining this document current. TVA will maintain this as a historical document, but any further updates of information or changes to policy will be communicated through separate correspondence.
