TVA NUCLEAR QUALITY ASSURANCE (NQA) PLAN (TVA-NQA-PLN89-A) - UPDATE -REVISION 5

In accordance with 10 CFR 50.54(a)(3) and 10 CFR 50.55(f)(3), changes to the quality assurance program that do not reduce commitments must be periodically submitted to NRC. Enclosure 1 is an update of changes to the TVA NQA Plan. This update addresses organizational changes within TVA Nuclear that affect the quality assurance program and describes refinements which have been made to the NQA Plan since the time that Revision 4 of the plan was implemented. In addition to describing refinements to the NQA Plan, this update incorporates changes which have previously been submitted to NRC on February 25, 1994, and which have been proposed to NRC on November 15, 1994, and March 7, 1995.

Enclosure 2 provides cross-reference of the changes made from Revision 4 to Revision 5 of the NQA Plan and provides appropriate justifications.

Revision 5 of the plan is being distributed to holders of controlled copies within TVA and is planned to be implemented at Bellefonte, Browns Ferry, and Sequoyah Nuclear Plants no later than June 15, 1995, and by fuel load for Watts Bar.
