SUBJECT: TERMINATION OF YOUR NRC RADIOACTIVE MATERIALS LICENSE

By letter dated May 30, 2008, you informed the U.S. Nuclear Regulatory Commission (NRC) that you wished to terminate your NRC radioactive materials license. The NRC Form 314 dated May 30, 2008 stated that all radioactive material had been transferred to Insight Diagnostic Imaging (License No. 11-29290-01) who is amending their license to add locations of use previously authorized on License No. 11-27738-01.

The supporting documentation to the NRC Form 314 also provided a copy of the latest leak test results. The leak test results document that there was no evidence of leakage of radioactive material from the sealed source. The supporting documentation to the NRC Form 314 stated that the licensee also possessed radioactive materials with radioactive decay half-lives of less than 120 days. A review of the historical file supported that only short lived radioactive materials were possessed by the licensee. The NRC staff has reviewed the supporting documentation to your NRC Form 314. Based on the documentation submitted and a review of your historical file, the staff concluded that all licensable radioactive material has been removed from the facility and the facility at 740 McKinley Avenue, Suite 202, Kellogg, ID 83837-2533, is suitable for unrestricted use in accordance with 10 CFR 20.1402, "Radiological Criteria for Unrestricted Use." Based on these conclusions, no further remediation or actions with respect to NRC regulated material is required.

Please find enclosed Amendment No. 12 to License No. 11-27738-01, authorizing your license termination. An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(20)(i).

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC Public Document Room or from the NRC's document system (ADAMS). 
