

## 1. DESCRIPTION OF FACILITY

### a. LOCATION:

The New Haven Depot is located three miles east of New Haven, Indiana on State Route 14 (New Haven is part of the Ft. Wayne, IN SMA). In addition to road access, the depot is served by the Norfolk Southern Railroad.

### b. LAND:

#### 1. Land & easements:

The current boundaries encompass some 246 acres of land of which DNSC uses 16 acres for storage. There are also warehouses and support structures as described in "d. Improvements" below. There are no easements.

#### 2. Acquisition:

The New Haven Depot, which is owned by the General Services Administration (GSA), was transferred to GSA from the US Army. DNSC has no record of the exact date.

#### 3. Surrounding land use:

The depot is bordered on the north by light industrial and on the other three sides by farm and open land.

### c. HISTORY:

New Haven Depot was originally constructed as a US Army ordinance facility in 1942 and was used as such during World War II. At that time it contained approximately 400 acres. Since then 164 acres including the structures thereon have been sold to the private sector and are currently used for warehousing and light industry. In 1984 the operation of the physical plant was delegated to DNSC by GSA. In 1989 an evaluation of the fire protection system indicated that the fire sprinkler system and much of fire mains should be replace. Also the electrical distribution system is obsolete and it too should be replaced. The upgrade of the electric system has been designed and is pending funding. The replacement of the sprinkler system is in GSA design. (March 91).

### d. Improvements:

The depot contains the structures listed below as well as both paved and gravel roads and 14.5 miles of railroad.
